

## LandPro Promise: 10-year Limited Tractor Warranty Acknowledgment Form

**New Compact Utility Tractors (1000-4000 series) purchased between March 1<sup>st</sup>, 2019 and Feb 28<sup>th</sup>, 2020 will receive the John Deere standard warranty; 2-year/2000 hour limited full warranty and a 6-year/2000-hour limited engine and powertrain warranty.** (Refer to the Full John Deere warranty statement for coverage and coverage exclusions)

These tractors are also eligible to receive the “LandPro Promise: 10-year Limited Tractor Warranty” (hereafter referred to as the LandPro Promise); a limited engine and powertrain warranty from LandPro Equipment that extends the John Deere limited engine and powertrain warranty to 10 years or 1000 hours of use, whichever comes first. The LandPro Promise is only redeemable at LandPro Equipment and is subject to the eligibility requirements outlined below.

**To be Eligible:** In addition to the terms and conditions outlined below regarding the John Deere limited Engine and Powertrain Warranty, the original purchaser must arrange to have LandPro Equipment complete all tractor fluid and filter maintenance as per the John Deere recommended maintenance schedule outlined in their owner’s manual for the duration of the extended warranty term. This includes, but is not limited to, yearly engine oil and filter changes. Transportation fees and maintenance parts/labor fees are the responsibility of the customer.

The LandPro Promise is nontransferable and has no cash value. Coverage and coverage exclusions mirror that of the John Deere Limited Engine and Powertrain Warranty below; Any reference below to “Authorized Dealer” shall mean LandPro Equipment with regards to the LandPro Promise.

### John Deere Limited Engine and Powertrain Warranty:

**Compact Utility Tractor Powertrain Warranty - Engine:** cylinder block, cylinder head, valve covers, oil pan, emissions control components, timing gear covers, flywheel housing, and all parts contained therein. **Powertrain:** transmission, transmission case, differential and axle housings, clutch housings, MFWD front axle assembly, and all parts contained therein (does not include external drivelines, dry clutch parts, or steering cylinders).

**WHAT IS NOT WARRANTED** – Pursuant to the terms of these warranties, JOHN DEERE and/or LANDPRO EQUIPMENT IS NOT RESPONSIBLE FOR THE FOLLOWING: (1) Used Equipment; (2) Any Equipment that has been altered or modified in ways not approved by John Deere, including, but not limited to, setting injection pump fuel delivery above John Deere specifications, (3) Depreciation or damage caused by normal wear, lack of reasonable and proper maintenance, failure to follow operating instructions/recommendations; misuse, lack of proper protection during storage, vandalism, the elements or collision or accident; (4) Normal maintenance parts and/or service, including but not limited to, oil, filters, coolants and conditioners, cutting parts, belts, brake and clutch linings.

**SECURING WARRANTY SERVICE** – To secure warranty service the purchaser must, (1) Report the Equipment defect to an Authorized Dealer and request warranty service within the applicable warranty term; (2) Present evidence of the warranty start date with valid proof of purchase; and (3) Make the Equipment available to an Authorized Dealer within a reasonable time.

**NO IMPLIED WARRANTY, REPRESENTATION OR CONDITION** – To the extent permitted by law, neither John Deere nor any company affiliated with it makes any warranties, representations, conditions or promises express or implied as to the quality, performance or freedom from defect of the Equipment covered by these warranties other than those set forth above, AND NO STATUTORY OR IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS ARE MADE. TO THE EXTENT LEGALLY REQUIRED, ANY IMPLIED WARRANTIES OR CONDITIONS SHALL BE LIMITED IN DURATION TO THE APPLICABLE PERIOD OF WARRANTY SET FORTH ON THIS PAGE. THE PURCHASER’S ONLY REMEDIES IN CONNECTION WITH THE BREACH OR PERFORMANCE OF ANY WARRANTY ON JOHN DEERE EQUIPMENT ARE THOSE SET FORTH ON THIS PAGE. IN NO EVENT WILL THE DEALER, JOHN DEERE OR ANY COMPANY AFFILIATED WITH JOHN DEERE BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. (Note: Some jurisdictions do not allow limitations on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages so the above limitations and exclusions may not apply to you.) In the event the above warranty fails to correct purchaser’s performance problems caused by defects in workmanship and/or materials, purchaser’s exclusive remedy shall be limited to payment by John Deere of actual damages in an amount not to exceed the amount paid for the Equipment. This warranty gives you specific legal rights, and you may also have other rights which vary from jurisdiction to jurisdiction.

- ☐ I acknowledge that to maintain eligibility for the LandPro Promise it is my responsibility to arrange and pay for LandPro Equipment to complete all recommended fluid and filter changes as per the maintenance schedule in my owner’s manual for the first 10 years of ownership or I forfeit the LandPro Promise Warranty coverage.
- ☐ I acknowledge that at a minimum, the maintenance schedule requires annual engine oil and filter changes. This service must be completed by LandPro Equipment for the first 10 years of ownership or I forfeit the LandPro Promise Warranty coverage.
